



## Info Sheet on ODS Licensing 2010 Myanmar



### Introduction

The data provided here has been selected based on its possible usefulness during daily activities related to trans-boundary movements in ODS.

Lists of registered importers and exporters for each country should facilitate the process of issuing a license as the officer could immediately see whether the actors (importers/exporters) are registered in the other country, and whether the substance / equipment can be imported from or exported to another country. It would also be useful to know which person to contact in another country that could give you direct information that can help during issuing of a license related to an import from or an export to that country, while executing controls at the border or during an investigation of possible illegal trade.
